The mission of the Program for the Deaf and Hard of Hearing in the South Carolina Department of Mental Health is to make sure that deaf and hard of hearing adults and children can access all of the available public mental health services. The program serves consumers across the state through the network of community mental health centers operated by the Department. By a combination of direct and support services and programs, we provide a variety of specialized community, residential and inpatient services using American Sign Language and English with a strong relationship to the Deaf community.

Staff of the program are specially trained to meet the needs of clients who are deaf or severely hard of hearing. Several staff are Deaf themselves and all are fluent in American Sign Language.

- Individual, Group and Family Counseling
- Consultation, Education and Prevention
- Assessment and Case Management

- Clinic and Community Based Services at each of the community mental health centers.
- Residential Programming.
- 24 hour-a-day TTY/TDD Crisis Line.
- Inpatient programming

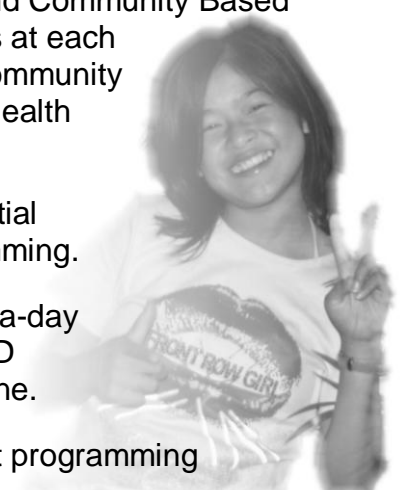
